

MELLOR PARISH COUNCIL – EMERGENCY POWERS Doc Ref MPC EM 15.04.2021

Due to the continuing imposition of Covid restrictions for Mellor, it is agreed that from 9.00pm on Thursday 15 April 2021, Mellor Parish Council will, until further notice:

- I. Empower Chairman (Cllr. Marsden) & Vice Chairman (Cllr. Hymas) to remain in post for the duration of these Emergency Powers
- II. Suspend all Parish Council meetings and amend the Parish Council's standing orders by including these Emergency Powers as a codicil to the existing standing orders and financial regulations, following approval by a majority of Parish Councillors
- III. Subject to approval by a majority of Parish Council members by email ; Continue to consider and act to close the children's playground owned by the Parish Council, if necessary and appropriate, dependent on latest Government & Local Authority guidance.
- IV. As Landlords The Parish Council requests Mellor Community Association Trustees to continue with the closure of Mellor Village Hall if the designation of Risk Area is deemed to be above Level 2 High Risk.
- V. Delegate all powers and decision making of the council to the Parish Clerk/ RFO (*except those that are prohibited by legislation*) who shall consult with and seek approval from **Nicholas Marsden – Chairman & John Hymas – Vice Chairman**. In the event that either the Chairman or Vice Chairman is unavailable, then another parish councillor shall be required to consider the action/decision in lieu.

This delegation of powers shall remain in force until such time as the Government announces a relaxation in the Social Distancing Advice to enable regular Parish Council Meetings to resume without risk to the health and wellbeing of:

- members of the public
- parish councillors
- the Parish Clerk
- the press
- any of whom may/will be in attendance.

For clarity, these emergency powers can be lifted at any time should the national emergency be downgraded and can be extended by the Parish Clerk in consultation with and with the agreement of the majority of the parish councillors if the situation is still prevalent. However, in any event, these powers must again be reviewed after 90 days and can only be further extended by a resolution supported by a majority of parish councillors. Each voting member shall register his/her vote (for or against) with the clerk by email.

The Parish Clerk should be instructed to work from home and communicate using e-mail or telephone. Cheque signing should comply with existing authorities, but not be done "face to face". If cheque signing is needed, this must be carried out by prior appointment, outside and with face masks & all social measures in force.

The Chairman, Vice Chairman and Clerk/RFO should consider establishing a system of virtual conferencing for link ups when necessary / appropriate.

Subject to the inclusion of any items approved at the Parish Council meeting held on 17 December 2020, Mellor Parish Council shall freeze all grant funding (unless pre-approved) and unessential spending unless approved by the majority of councillors using email. This will not apply to spending related to property owned by the council, wages or where expenditure is contractual or essential to the running of the council.

Communication with the press and public shall be the responsibility of the Clerk after due consultation with the Chairman, or in his absence, the Vice Chairman.
